Dear Sir:

The claim is made by Louis B. Murphy, Indian of this jurisdiction who is the owner of Indian allotment No. 95 in the Mono Basin, and comprising 120 acres; that a band of sheep owned by you and under the care of John Matia, traversed his place and ate all the feed. Further that no lease had been accomplished or arrangement made either with the Indian or through this office whereby permission had been granted for the sheep to feed on this land. The Indian now asks damages in the matter and under the circumstances, it would seem that he was justified in his request.

He avvadges that in former years he received \$100. as an annual rental, but this year he received nothing.

The land in question is described as the SW-1/4 of the SE-1/4, the SE-1/4 of the SE-1/4 of Sec. 26 and the NE-1/4 of the NW-1/4 of Sec. 35 Tp. 1 N.R. 26. E.X.D.M.-containing 120 acres. The land is under the jurisdiction of the Indian Service for the Indian and any lease accomplished should be made through this office. In view of the present late date however, no lease can be accomplished for the past year but a satisfactory settlement of the damages is requested.

I took this summons to Mr. Van Loon but he could not make anything out of it. He does not know who the Sierra Land and Water Company is, but thought it might be a company that went bankrupt a few years ago.

I took the paper to the City offices but neither Mr. Leahay nor Mr. Hendricks were in yesterday. I shall go to City offices again this morning when I expect to see Mr. Hendricks. He may be able to tell me something about the company. If he knows anything about it, I shall write a P.S. to this letter.

DEAR MR. PARRETT:-

Your letter enclosing summons and copy of Complaint against Louis Murphrey, as a defendant in case of Sierra Land and Water Co. vs. Cain Irrigation Co. et al, is at hand. This case has during the past 30 days assumed some activity, and no doubt will be before the Court as soon as Judge Parker returns from S.F. where he has been holding court during the Winter. The subject matter involves water rights in and about Mono Lake- and I see the names of a number of the early settlers and homestead locators of that vicinith.

I would suggest that Louis Murphrey-- acknowledge service of summons and complaint, and if he feel that he has any possible interest in the land, water, or water right surrounding the lake,--that he file a general demurrer to the complaint--

It is difficult ,at this time, to grasp what the plaintiff expects to settle by this suit-- as it is generally understood that Court Decrees, rendered some years ago have established the title to water right in that vicinity more than sufficient to absorb all the water flowing in that territory.

The Plaintiff's Articles of incorporation were file in Mono Co, in 1914, but nothing has been done until recently-- last week the Plaintiff filed Notice of Les Pandence in this suit.

I am returning the summons and complaint , as requested.

Dear Mr. Swaim:

Regarding the summons and complaint against Louis Murphy as one of the defendants in the case of Sierra Land and Water Co., vs. Cain Irrigation Co., et al; I enclose the letter received from Chas. L. Hayes, District Attorney of Mono County, regarding the matter.

Louis Murphy has an allotment in the Mono Lake Basin. His water right is from the waters of Rush Creek. I think there is something about the water rights as decided for the Indians of this section, in the file Mono Lake Indians.

Mr. Hayes states that Louis should acknowledge service of summons and file a demurrer to the complaint. I imagine it would be quite difficult for Louis to get to Bridgeport at this time of year and I would scarcely know just what action to advise. I would believe however, that if he signed an acknowledgement before you, advising that he had received the summons and complaint, and stating in a written statement signed by him, that he had certain lands in the Mono Lake basin, has used such lands for a period of years, and claimed a water right for a certain acreage based on beneficial use for a period of years past; that this sworn statement by him might cover his case. I would suggest that you advise Louis of the District Attorney's letter so that he can take proper action in the matter.

Dear Sir:

I am returning the Mono County Court summons you handed me some time ago, and which I forwarded to Capt. Garrett. Mr. Garrett advises that you go to Bridgeport at once if you can get there and acknowledge the summons and file a demurrer to the complaint. You should take the summons with you and go to see Attorney Charles L. Hayes. If you cannot get to Bridgeport you can bring the summons to Bishop and I will see if we cannot acknowledge the summons and send in a general demurrer to the complaint, but it would be better to go to Bridgeport, in my opinion.

The legal description of your land is as follows:
NE/4 of NW/4 of Sec. 30, and the SW/4 of NW/4 and SW/4 of SE/4 of Sec. 26,
T. 1 N., R. 25 E., M.D.M. in Mono County, California. 120 acres.

Trust patent issued to you by the U.S. Government Sept. 23, 1907.

I cannot find that any definite water right has been decreed you for the land but you are entitled to amount of water which you have been using in past. Attorney Hayes will know how to file a demurred, so you had better see him as soon as possible.


