1. Call to Order and Roll Call – John Tierney

GBC IAC Chair John Tierney called the meeting to order AT 7:00 a.m. and a roll call was taken. There was a quorum.

Public Comment (see foregoing notation regarding public comment) Public Comment statement read by John Tierney. There was no public comment.

Approval of Minutes

GBC Institutional Advisory Council reviewed the minutes of the GBC IAC meeting on March 18, 2021. Dave Roden made a MOTION to approve the minutes; Wil Moschetti seconded the motion; **MOTION was APPROVED**.

GBC IAC Chair Report

John Tierney requested introductions of all present. GBC staff, NSHE staff and members of the IAC in attendance introduced themselves.

John Tierney asked Chris McAnany to report on Elko County School District. Chris said dual credit is an important partnership that has existed for quite some time and continues to expand. We do need to work on more dual credit for the outlying schools. The district is becoming more efficient with online education so it should only get better from here.

John Tierney reported we are short on members to the IAC and asked Mardell Dorsa to expand upon the numbers. Mardell reported there will eight terms expiring in December 2021. Of those 2 are vacant and 4 will expire. Two can serve again if they would like. In addition, Delmo Andreozzi has also just resigned (his term expires in December 2023). At the first meeting in September of the new academic year of 2021-2022 the IAC must also elect a chair and cochair who will serve for 2 years. Wil Moschetti reminded the group that in the procedures it states members who have missed more than three consecutive meetings can be removed from the IAC. John Albrecht said it would be better to reach out to those individuals to see if they would just resign. Regent Cathy McAdoo asked John Albrecht, GBC Legal Counsel, if the IAC was allowed to discuss or mention names of interested parties. John Albrecht said that mentioning a name is not going to be an issue. The issue is when you start discussing their qualifications in any way. John Albrecht recommended that if you have someone in mind to serve on the IAC, forward that information to the president's office to vet and contact the person.

John Tierney talked about the success of the Teacher's Summit on April 27th. John thanked all the GBC staff that was instrumental in putting on this statewide event. 154 people attended the inaugural event. A Facebook page has been created to maintain contact with the participants. John is hopeful that GBC can put on the summit again next year.

IAC Member Reports

Dave Roden talked about the Winnemucca Groundbreaking event on May 7, 2021. He thanked everyone who could make it out for that.

Caroline McIntosh had no report, but congratulated Dave Roden and the Winnemucca GBC staff, and everyone involved in the success of the building campaign in Winnemucca.

Barbara Gallagher reported in the legal community that civil trials are moving forward, and restrictions are finally being lifted. She missed the last IAC meeting because of a jury trial in Winnemucca.

Don Miller reported that the dictionary campaign to provide dictionaries to all 3rd graders in Elko County has been completed for this year.

Wil Moschetti thanked Dave Roden for his work in Winnemucca. He asked if GBC has a role in advertising to get more people vaccinated. Jennifer Sprout said we have been involved in some of the marketing for vaccination campaigns. GBC teamed up with the County with the Mask Up Campaign.

President's Report

President Joyce Helens continued the conversation on the Pandemic for a little bit. Because of our close relationship with UNR we were utilizing what they were doing. With our protocols in place GBC did well in not spreading the virus. March to September we had 1 case and it was from the student's workplace. Since we were already offering online courses and were good at it, we lead the way. We know how to do online and that is why we were so successful. Our enrollment increased 5 % over a previous boom year. GBC was the only one in the state to do that. We ran a great marketing campaign where it said the world has changed, but we haven't, and it worked. President Helens said she had weekly ZOOM meetings with all of GBC Staff to keep everyone informed and moving forward.

In April President Helens presented the GBC Metrics to the Board of Regents and it was very well received. We are very proud of our outcomes. Our marketing campaigns were successful; we maintained our Dual Enrollment which was up 20%. Creating and supporting healthy communities is our mission. We are talking to legislators who have never heard our perspective of creating a well-lighted pathway.

President Helens presented the GBC Metrics presentation that was presented to the Board of Regents in April 2021. Some highlights:

- Objectives were adopted by the Board of Regents.
- GBC Service Area is 86,000 square miles and we are more frontier than rural.
- Through last year and the pandemic budget cuts continued, but our FTE has grown. FTE is how many courses are being taken.
- Adults are getting degrees in a part time way.
- Race/Ethnicity headcount is growing in people of color. 66% female; 34% male; enrollment of Hispanics is increasing.
- GBC graduation rate is 43.3% very high compared to other institutions in Nevada and the USA.
- Peer institutions there are no other colleges to compare us with.
- IPEDS how they measure the gap. Offering less certificates means we are succeeding in creating a well-lighted pathway for students as they are staying for the degrees.
- Full-time students in cohorts are highly successful and receive more degrees and certificates than part-time students. We are looking at how we can create cohorts with the part-time students to duplicate that success.
- GBC has 68% retention compared with the 61% national average.
- Distance Education we serve Nevada but 10% is out of state students. GBC is a good deal; we can increase out of state tuition and still be a good deal. We have SGA

participants from all over the States and the world. GBC received a commendation for our accreditation agency on our distance education technology... they saw our success.

- GBC is providing a well skilled workforce (nursing/teacher education).
- 3+1 Social Work Program with UNR is a fine achievement of the partnerships that we have with UNR.
- Closing the Achievement Gap by requiring mandatory orientations.
- Bringing in many grants for infrastructure.
- UNR/GBC partnerships creates ease of transfer. Hired a transfer coordinator; Social Work program; Nevada INEBRE. UNR provided back-offices services that have expanded to construction management services for the Winnemucca building saving GBC \$150,000. GBC is part of the Northern Command Security Police Services under UNR. Working on an AAS transfer with UNR. Working with Mackay School of Mines, Industry/suppliers, and nonprofits to create the Mining School of Excellence.

Vice President for Student & Academic Affairs Report

Jake Rivera reported on a 6.5% decline in enrollment for Spring. We are now enrolling for Summer and Fall. Summer is now down 12% compared to last year. There is a reason why we see declines. Last spring classes were out earlier, and we offered more classes last summer than we are offering this summer. The numbers will improve over the coming weeks. Fall is off to a good start. FTE is up 15% and headcount is up 26%. The past academic year we saw strong numbers in advisement, an increase in text messages to potential students encouraging them to register, and improvements to student housing and in the recreation room. Student housing engages students virtually in their planned activities.

The Student Affairs team recently participated in a NSHE conference on best practices and several of our staff members presented.

The GBC IDEAS committee focus on inclusion and equity and have developed a college diversity plan. The college is also working on a technology plan.

The virtual commencement is on track and Jake will let Jennifer Sprout talk about that later.

Karl Stevens reported GBC is looking at a ZOOM enhancement product that will allow faculty to create more robust presentations. Karl talked about the new online student orientation that Tom Cunningham and Jennifer Brown helped to create. It is called Smart Start Orientation and will be required of all new students. It will help the student understand the importance of advisement, financial aid, etc. Wil Moschetti asked if the college uses Google Meets. Karl said Google Meets is not something the college is officially using, but it is available to us as the college uses Google for email and calendaring.

Communications and Marketing Update/Foundation Update

Jennifer Sprout reported that the virtual commencement link will be distributed and shared on all social platforms next week. Her department is working on the fall and summer campaigns.

The Foundation has started the Welding Lab Expansion capital campaign. Meetings have been scheduled with major mines and support industry to ask for support. The GBC Foundation website is being revamped and will be much more efficient and user friendly.

The GBC Foundation Director Geneil White will start in June.

Faculty Senate Update

Kevin Seipp is the new Faculty Senate chair for the upcoming academic year. He had nothing to report other than the Senate met last Friday for the final time before the summer break.

Regent McAdoo's Comments

John Tierney asked Regent McAdoo if she had any comments. Regent McAdoo echoed President Helens' sentiment earlier in the meeting that her presentation to the Board of Regents on the GBC Metrics in April was very well received. Regent McAdoo stated she is a graduate of GBC and is very proud of the work that the college is doing.

Regent McAdoo stated she is a very strong advocate for keeping NSHE as we know it now as it serves all Nevadans. Regent McAdoo was pleased to attend the Winnemucca Groundbreaking Ceremony and to meet Mr. Stoltz from the Pennington Foundation.

Regent McAdoo said the next Board of Regents' meeting is scheduled for June 10 and 11 in Las Vegas and Reno but could be moved to all virtual. She encouraged all to join in as it will keep you well informed.

Regent McAdoo appreciates all the work of educators in rural Nevada. They are doing a very good job in these tumultuous times.

The next GBC Institutional Advisory Council is tentatively scheduled for September 16, 2021.










GBC FALL HEADCOUNT & FTE TRENDS




GBC Fall Full-Time & Part-Time Headcount Trends

GBC Fall Headcount Trends by Race/Ethnicity






2019 Reported Year Peer Institution Graduation Rates


Graduation Rate by Race/Ethnicity Year: 2020 (First-Time/Full-Time degree seeking students)





Great Basin College Peer Institutions: Number of Students Receiving Degrees and Certificates





Great Basin College Percent of Students by Race/Ethnicity Receiving Degrees and Certificates




Great Basin College Fall to Spring Retention First-Time Full-Time Degree Seeking Students


