7. HOUSING FEE CHANGE UPDATE INFORMATION

Vice President of Business Affairs, Sonja Sibert, will address student fee changes to GBC Housing rates. SGA will be asked for review, input and potentially future approval.

- This is an annual process to bring forward any changes in student fees. As part of this process we involved students, administration, faculty, staff, and others that are directly involved with the proposals.
- Last year at this time the only fee change that came forward was the technology fee by \$2 a credit.
- This year the only fees that are coming forward are the fees for student housing and just for the cost of the room. Nothing as far as application fees or any of the other fees associated with housing are being proposed to change at this time.
- The majority of students, 67%, that responded to the survey said that the minor change of around 10% per semester would not have any effect on them financially, or very little impact.
- The cost to keep the buildings up and repair them increases every year. Part of that fee increase would go for that.
- This will also go towards upgrading some amenities including the basketball courts and adding a volleyball court, which would be available to all students and housing regardless of where they are at.
- They are also looking at doing some technology upgrades in Griswald Hall itself and adding additional wireless points, so wifi access will be better. Also increasing some of the technology devices that are available to students in the Griswald Computer Lab.

Regarding gift certificates and gift cards:

- No matter what the dollar amount, it could become taxable income to the recipient. Therefore, Sonja would need to know the name, contact information, and the dollar amount of each recipient for however many winners there are. This would be so they can track that for the taxable income resources.
- Gift cards and gift certificates cannot be purchased with a GBC company key card or credit card. You would want to go somewhere at your location who accepts departmental purchase orders or someone would need to buy them personally and be reimbursed. Or you can talk to your senate directors and possibly they'd be willing to purchase them with petty cash.
- You can also get donations from companies. You need to keep track of what you get from each company and the dollar value. If that happens then Sonja will work with you on that.

Senator Gurr motioned for approval of the \$50 for supplies for Ely's Count The Critters Jar Raffle. Senator Dempsey seconded.


