9. WINNEMUCCA BUILDING – FUNDING FOR FURNISHINGS **FOR POSSIBLE ACTION**

Vice President for Business Affairs, Sonja Sibert, is requesting funding from SGA to assist with funding the purchase of furnishings for the new Health Sciences and Technology Building at the Winnemucca Center. Total cost of all furnishings for the building is estimated to be \$540,000. Vice President Sibert is asking SGA to consider assisting with funding for furnishings for the conference room, outdoor areas, and/or corridor areas.

Conference Room - including conference table & chairs for 10 people \$16,000

Outdoor areas – including benches and tables - \$23,850

Corridors – including lounges, group and individual tables and chairs, and benches - \$68,300

The new building in Winnemucca will be approximately 13,500 sq ft and has a total project cost of \$9.8M. Funding for this building is provided primarily by donors. Major donations to date are The William N. Pennington Foundation \$5.5M, Humboldt General Hospital \$1M, and Barrick Gold \$300,000. This new building will house all the health science related programs, including Nursing, Certified Nursing Assistant and Paramedic. It will also have classrooms and lab space for the Electrical Technology Program. Construction is scheduled to begin in April 2021 with completion of the project in June 2022. Classes in the Fall 2022 semester will be held in this building.
